The minimum rates of extra-duty employment pay rate are as follows:

Extra-Duty Type	Regular Day	Sunday/Holiday
Extra-Duty Employment	\$22.00 /hr	\$32.00 /hr
Extra-Duty Employment – Hazard Pay (i.e. Traffic Control)	\$25.00 /hr	\$35.00 /hr
Location Supervisor	\$30.00 /hr	\$45.00 /hr
Location Supervisor – Hazard Pay	\$33.00 /hr	\$50.00 /hr
Event Supervisor	\$35.00 /hr	\$50.00 /hr
Event Supervisor – Hazard Pay	\$38.00 / hr	\$55.00 /hr
Event Commander	\$40.00 /hr	\$55.00 /hr
Event Commander – Hazard Pay	\$43.00 /hr	\$60.00 /hr
Barricade Delivery – Type 1 / A Frame	\$27.00 /hr	\$41.00 /hr
Barricade Delivery – French	\$30.00 /hr	\$45.00 /hr
Cost Recovery Fees		
City of Savannah Cost Recovery Fee – Uniformed Officer	\$1.00 /hr	\$1.00 /hr
City of Savannah Cost Recovery Fee – City Vehicle	\$6.00 /hr	\$6.00 /hr

- Events requiring five (5) or more officers to work simultaneously require a minimum of one (1) Location Supervisor.
- Events requiring two (2) or more Location Supervisors to work simultaneously require a minimum of one (1) Event Supervisor.
- Large scale events, as determined by the Outside Employment Office or the Chief of Police, require an Event Commander.


- All rates are billed at a four (4) hour time minimum.
- Officers shall note negotiate extra-duty lower pay rates with employers.
- Cost Recovery rates apply to all extra duty jobs.

Extra-Duty jobs that are currently being handled by an SCMPD Coordinator may remain at the same rate of pay until such time that the hourly rate of pay agreed upon is renegotiated or the job is terminated.

This order supersedes all written directives issued prior to 09/04/15, pursuant to Extra-Duty Employment Minimum Pay Rate.
